This Lease Agreement is not assignable and no refund of storage charges shall be made upon early termination of this Lease Agreement. The lessor SHALL NOT be held liable for damages or claims arising out of any damage to lessee's stored property, sustained as a result of theft, fire, acts of third parties, corrosion, roof collapse, vandalism, snow, or by the elements. Lessee waives any rights, including any subrogation rights, to recover against lessor or his agents or its insurer for any such loss or damage. LESSEE SHALL SELF-INSURED against all loss. Lessor is not responsible for personal items left aboard storage boat. Boats will be removed from storage in spring in the most expeditious order. Seven day notice is required for spring boat delivery. Lessee agrees to pay winter storage changes as stated above before any boat/watercraft is returned. In the event of default, Lessee agrees to pay all costs of collection including reasonable attorney's fees.

AUTHORIZATION:

By signing this Agreement, we authorize Minnetonka Boat Club & Rental or its assigns to access all information at the Minnesota Department of Natural Resources regarding our boat/watercraft and specifically authorize the MN DNR to release all information including lien holder information to Minnetonka Boat Club & Rental or its assigns.

This Agreement is assignable to Minnetonka Boat Club & Rental to any other facility/marina that Minnetonka Boat Club & Rental in its sole discretion deems appropriate.
